Dear Sir/Madam,

This is a corrigendum to the intimation submitted to the Exchanges today i.e. March 11, 2026 relating to the penalty imposed on the Company by Office of the Commissioner of Goods & Service Tax and Central Excise, Salem, Tamil Nadu.

By way of this corrigendum, we wish to submit that the tax amount involved in the instant case has been already paid by the Company before the inception of the tax dispute.

Accordingly, in the said order, the adjudicated authority has duly appropriated the tax demand of Rs. 126,19,24,144/- and only imposed interest and penalty for which details pursuant to Sub-Para 20 of Para A of Part A of Schedule III of SEBI LODR is as under:
