1. Introduction

Uno Minda, hereinafter referred to as “We” or “Us” or “Company” or “Organization” has created this Privacy Notice to inform its website users regarding the collection, use and disclosure of Personal Data collected from this website.

We hereby request individuals to read this statement, together with any privacy statement we may provide on specific occasions when we are collecting or processing Personal Data about them so that they are aware of the processing of their Personal Data throughout its lifecycle.

2. Applicability

5. Purpose of Processing your Personal Data

8. Data Retention
