1. Introduction

Uno Minda, hereinafter referred to as "We" or "Us" or "Company" or "Organization" has created this Privacy Notice to inform its website users regarding the collection, use and disclosure of Personal Data collected from this website.

We hereby request individuals to read this statement, together with any privacy statement we may provide on specific occasions when we are collecting or processing Personal Data about them so that they are aware of the processing of their Personal Data throughout its lifecycle.

2. Applicability

This Notice applies to the Personal Data of all website visitors and individuals who provide their Personal Data via this website to Uno Minda, and all such individuals are hereinafter referred to as the "Data Principal".

- c. Via cookies.

5. Purpose of Processing your Personal Data

As part of your relationship with us, the following may be the purpose of collecting and processing your Personal Data:

6. Legal Grounds for Processing Personal Data

- b. Voluntary disclosure: processing for which you have voluntarily provided your Personal Data.
- c. Legal obligation: processing required to comply with relevant laws and regulations.

7. Children's Personal Data

8. Data Retention
