With reference to the aforementioned subject and the Initial Intimation, we wish to inform you that the Company had filed a writ petition before the Hon'ble High Court of Karnataka, challenging the adjudication order issued by the Department of Commercial Taxes, Office of the Joint Commissioner of Commercial Taxes (Enforcement)-1, Mysuru, Karnataka dated January 08, 2025.

Upon considering the Petition, the Hon'ble High Court has directed the GST Department to pass an appropriate order under Section 73 of the CGST Act within one week from 05.05.2025.

In compliance with the said directive, the Company had submitted a letter dated 06.05.2025 to the GST Department, requesting revocation of the earlier adjudication order and issuance of a fresh order under Section 73 of the CGST Act, as per the directions of the Hon'ble High Court.
