I, Devesh Kumar Vasisht, Partner of M/s Sanjay Grover & Associates, Company Secretaries, having office at B-88, First Floor, Defence Colony, New Delhi-110024, was appointed as Scrutinizer by the Board of Directors of UNO MINDA LIMITED (Formerly Known as MINDA INDUSTRIES LIMITED) ("**Company**") in its meeting held on May 24, 2022 for the purpose of scrutinizing the voting process i.e. remote e-voting and e-voting at 30thAnnual General Meeting ("**AGM**") under the provisions of Section 108 of the Act, read with the Rules and General Circular No. 20/2020 dated May 5, 2020 in relation to clarification on holding of Annual General Meeting ('**AGM**') through video conferencing ('**VC**') or other audio visual means ('**OAVM**') read with General Circulars Nos. 14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15, 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 02/2021 dated January 13, 2021, 10/2021 dated June 23, 2021,19/2021 dated

December 8, 2021 and General Circular No. 2/2022 dated May 5, 2022 in relation to 'Clarification on passing of ordinary and special resolutions by companies under the Companies Act, 2013 and the rules made there under on account of the threat posed by COVID-19' (collectively referred to as '**MCA Circulars**') and the Securities and Exchange Board of India ('SEBI') vide its circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/79 dated May 12, 2020 in relation to 'Additional relaxation in relation to compliance with certain provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015-COVID-19 pandemic' and Circular Nos. I submit my report as under:-

- The remote e-voting period commenced on Monday, 12 September, 2022 at 09:00 A.M. and ended on Thursday, 15 September 2022 at 05:00 P.M. via e-voting platform on the designated website of National Securities Depositories Limited ("NSDL"), Authorized Agency to provide e-voting facility viz.: <u>https://www.evoting.nsdl.com.</u> The Company provided e-voting facility to the Members who participated / attended through VC/OAVM to enable such Members to cast their votes, if they had not cast their vote earlier through remote e-voting.
- 2. The Members of the Company as on the "Cut-off Date" i.e. Friday, 09 September, 2022 were entitled to avail the facility of remote e-voting as well as e-voting at the AGM on the proposed resolutions as set out in AGM Notice.

3. The total paid up Equity Share Capital of the Company as on Friday September 09, 2022 Regional Regiona Regional Regional Regiona Regional Regional Regio Hundred Seventy Two Only) divided into 57,23,00,086 (Fifty Seven Crore Twenty Three Lakh and Eighty Six) equity shares of Rs. 2/- (Rupees Two) each.

- 4. The management of the Company is responsible to ensure the compliance with the requirements of (i) the Act and the Rules made thereunder (ii) the MCA & SEBI Circulars; and (iii) the LODR Regulations related to e-voting in respect of the resolutions contained in the AGM Notice and also for ensuring a secured framework for e-voting.
- 5. My responsibility as Scrutinizers for e-voting at the AGM and remote e-voting is restricted to make a consolidated scrutinizer's report of the votes cast in 'Favour' or 'Against' the resolutions contained in the AGM Notice, based on the reports generated from the e-voting system provided by NSDL.
- 6. The votes cast through remote e-voting were unblocked in the presence of two witnesses i.e. Mr. Ayush Arya and Mr. Vipin Dhameja who are not in the employment of the Company.

- 7. After completion of e-voting at the AGM, the data of e-voting at the AGM was diligently scrutinized and reconciled with the records maintained by the Link Intime India Private Limited, Registrar and Share Transfer Agent ("RTA"). The Members exercised their voting rights either by remote e-voting or e-voting at the AGM.
