b. I confirm that we have no-objection if the meeting of the secured creditors of the **Transferor Company 3** to approve the Scheme is dispensed with by the Hon'ble National Company Law Tribunal, New Delhi;

c. I confirm that we hereby waive our right to object to the Scheme, at the meeting of the Secured Creditors, if any, convened by the National Company Law Tribunal, for approving the Scheme; and

d. I confirm that this no-objection to the Scheme shall also be considered as an approval under the Relevant Agreements.

4. The above no objection is given subject to the condition that all the terms and conditions of loan/facility documents executed by the Transferor Companies shall be in full force and effect and the securities created in Bank's favour by the Transferor Companies and/or any other third party will remain unaltered and shall be continued with the Transferee Company even after the amalgamation and no dilution of whatsoever shall be permitted till the entire facilities along with interest and other dues are fully repaid to the satisfaction of the Bank.
